Compared to last week: Not enough Current FOB trades last week for an accurate trend. Demand good. Severe storms are in the forecast over the weekend across the trade area. Supply included: 100% Feeder Cattle (76.8% Steers, 23.2% Heifers). Feeder cattle supply over 600 lbs was 98%. Unless otherwise noted, Feeder Cattle prices FOB based on net weights after a 2-3% shrink or equivalent, with up to a 15 cent slide > 600 lbs and up to a 20 cent slide < 600 lbs. Livestock reported this week originated from OK.
