## DOMESTIC MARKET HIGHLIGHTS

The market on frozen 8-16 lb. hens and 16-24 lb. toms is steady with steady to weak undertones. Demand light. Offerings moderate to ample. Frozen domestic 2024 production Grade A basted equivalent processor offering prices on a national basis for Grade A 8-16 lb. hens are 84.00-103.00 FOB and 16-24 lb. toms 86.00-105.00 cents FOB for current shipments. No trading reported.

The market on tom breast meat is steady to weak with fresh reported at unchanged to lower prices. Demand light to instances moderate with fresh tom breast meat slightly more active. Offerings moderate to moderately heavy, mostly moderate. The fresh destrapped tenderloin market is steady while frozen is steady with mixed undertones. Demand light to instances moderate. Offerings of fresh destrapped tenderloins light to moderate and frozen at least moderate. The white trim markets are steady with steady to barely steady undertones. Demand light. White trim offerings uneven ranging light to moderately heavy, mostly moderate. Further processed demand slow to moderate with some parts of the country more active than others. The 4-8 lb. breasts market is steady to weak. Institutional sized rib breast markets are steady to barely steady. Demand light to instances moderate. Increased activity was noted for current and deferred shipments with some reported at 135 delivered September/October. Offerings light to heavy, mostly moderate. The market on tom drums is steady to fully steady, wings steady to firm, and necks steady to instances weak. Tom wing demand moderate to good with 2-joints strongest, balance of tom bulk parts light to moderate. Offerings of tom 2-joint wings short to very light, balance light to moderate with necks longest. The hen bulk parts market is moderate to good on wings, hen drums and necks light to moderate. The thigh meat and bone-in thigh markets are firm. Demand moderate to good. Offerings very light to light. The fresh mechanically separated turkey market is steady, frozen steady to firm. Demand moderate. Fresh offerings light to moderate, frozen light. Trading heavy on 4-8 lb. breasts, balance slow to moderate.

## EXPORT MARKET HIGHLIGHTS

Trading slow. The market on tom necks is steady to barely steady, balance of parts and meat items steady to instances firm. Demand mostly moderate. Offerings very light to light.
