DOMESTIC MARKET HIGHLIGHTS

The market on fresh 8-16 lb. hens and 16-24 lb. toms is steady. The market on frozen 8-16 lb. hens is steady to instances firm and 16-24 lb. toms is steady with a steady to weak undertone. Demand light, best on hens. Fresh offerings light. Frozen Grade A 8-16 lb. hen offerings very light to light and 16-24 lb. toms mixed ranging light to moderate. Frozen domestic 2024 production Grade A basted equivalent processor offering prices on a national basis for Grade A 8-16 lb. hens are 94.00-105.00 FOB and 16-24 lb. toms 81.00-105.00 cents FOB for current shipments. No fresh trading reported, frozen slow. Frozen Grade A basted equivalent 8-16 lb. hens 104 FOB and 16-24 lb. toms 104-105 cents FOB for current shipments.

The market on frozen tom breast meat is steady to firm, fresh steady with a steady to weak undertone. Fresh destrapped tenderloin market steady with a steady to weak undertone, frozen steady. Tom breast meat demand light to instances good, best on frozen. Destrapped tenderloin demand light to moderate. Frozen tom breast meat offerings very light to light, fresh mixed ranging light to moderately heavy. Frozen destrapped tenderloins offerings very light to light, fresh light to moderate. The wing meat with skin market is steady, balance of white trims steady to firm. Demand light on wing meat with skin, balance of white trims light to moderate. Offerings light. The market on 4-8 lb. breasts is steady with steady to weak undertones, institutional sized breasts steady. Demand light. Offerings of 4-8 lb. breasts mixed ranging light to ample for needs and institutional sizes light to moderate. The tom 2-joint wing market is steady to weak, balance of tom bulk parts and tail markets steady to firm. Demand light to moderate on tom 2-joint wings, balance of bulk parts moderate to good. Offerings of tom 2-joint wings moderate to moderately heavy, balance of tom bulk parts very light to light. The thigh meat and bone-in thigh markets are steady to firm. Demand moderate to good. Offerings very light. The mechanically separated turkey market is steady. Demand moderate. Offerings light to moderate. Trading slow.

EXPORT MARKET HIGHLIGHTS

No trading reported. The market on tom bulk parts, frozen tom breast, tenderloins and thigh meat markets is steady to firm with tom 2-joint wings mixed. Demand light to moderate. Offerings mixed, mostly light.
