Compared to last week: Feeder steers not tested for Current FOB. Feeder heifers lightly tested and steady. Demand good as supplies are beginning to get lighter. Some much needed rain fell this past week hitting many of the drought areas. Supply included: 100% Feeder Cattle (58.3% Steers, 41.7% Heifers). Feeder cattle supply over 600 lbs was 100%. Unless otherwise noted, Feeder Cattle prices FOB based on net weights after a2-3% shrink or equivalent, with a 8-12 cent slide > 600 lbs. Livestock reported this week originated from GA, KS, OK, TX.
