Subscribe to all Cotton Market reports Spot quotations averaged 126 points lower than the previous week, according to the USDA, Agricultural Marketing Service's Cotton and Tobacco Program. Quotations for the base quality of cotton (color 41, leaf 4, staple 34, mike 35-36 and 43-49, strength 27.0 - 28.9, and uniformity 81.0 - 81.9) in the seven designated markets averaged 64.07 cents per pound for the week ending Thursday, December 19, 2024. The weekly average was down from 65.33 cents last week and from 75.32 cents reported the corresponding period a year ago. Daily average quotations ranged from a high of 64.73 cents on Friday, December 13 to a low of 63.37 cents on Thursday, December 19. Spot transactions reported in the Daily Spot Cotton Quotations for the week ended December 19 totaled 35,749 bales. This compares to 42,641 reported last week and 28,779 bales reported the corresponding week a year ago. Total spot transactions for the season were 295,246 bales compared to 385,073 bales the corresponding week a year ago. The ICE March settlement price ended the week at 67.91 cents, compared to 70.09 cents last week.

Southeastern Markets Regional Summary

Spot cotton trading was slow. Producer offerings and supplies were moderate. Demand was moderate. Average local spot prices were lower. Trading of CCC-loan equities was inactive.

Mostly cloudy conditions dominated the weather pattern across the lower Southeast during the period. Unseasonably warm daytime high temperatures were in the 60s and 70s with nighttime lows in the 40s and 50s. Heavy fog was observed in some areas mid-week. Scattered showers brought light rainfall to portions of west Georgia and northwest Alabama throughout the period. Precipitation totals measured from one-half of an inch to one inch of moisture. The moisture helped improve dry conditions in some areas of the region. Harvesting advanced at a good pace as weather conditions allowed. Gins continued to process backlogs of modules on gin yards.

Across the upper Southeast sunny conditions over the weekend gave way to overcast skies later in the period with foggy conditions observed. Daytime high temperatures were in the 60s and 70s with overnight lows in the 40s and 50s. Scattered showers brought very light precipitation to cotton-growing areas of the eastern Carolinas and Virginia during the week. Rainfall totals measured from trace amounts to around one-half of an inch of precipitation. Harvesting advanced at a good pace in between rain events. Gins continued to process backlogs of modules.

<u>Textile Mill</u>

Domestic mill buyers inquired for a moderate volume of color 41, leaf 3 and better, and staple 35 and longer for January through March 2025 delivery. No sales were reported, and no additional inquiries were reported. The undertone from mill buyers remained cautious as they continued to balance yarn production with finished product orders.

Demand through export channels was moderate. Agents throughout the Far East inquired for any discounted styles of cotton. No sales were reported.

- Even-running lots containing color mostly 41, leaf 3 and 4, staple 36 and 37, mike 43-49, strength 29-32, and uniformity 80-83 sold for around 71.00 cents per pound, FOB car/truck (Rule 5, compression charges paid).
- A moderate volume of color 41 and 51, leaf mostly 2 and 3, staple mostly 37 and 38, mike 43-52, strength 28-31, and uniformity 80-83 sold for around 69.00 cents per pound, FOB car/truck, Georgia terms (Rule 5, compression charges paid, 30 days free storage).

North Delta

Spot cotton trading was moderate. Supplies of available cotton were moderate. Demand was very light. Trading of CCC-loan equities was slow. Average local spot prices were lower. Business continued to move slowly. Producers continued to hope for stronger demand.

Thunderstorms brought seasonably cold weather to the territory throughout the reporting period. Daytime high temperatures were in the 40s to 60s. Cold rain showers dominated the region at night, dropping overnight temperatures to low 30s. Precipitation totals measured from trace amounts to around three inches of rain. According to the U.S. drought conditions Monitor, improved from mostly moderate drought to adequate soil moisture in most of the cotton-producing areas as widespread beneficial rainfall supplied much-needed moisture to dry fields. Fieldwork was active in areas firm enough to support equipment. Pressing operations continued in a few gins, while other gins expected to finish within the next week. A few plan to work into February. The Memphis Classing Office has gone from three shifts to one shift as they robustly work to finish the season.

South Delta

Trading of spot cotton and CCC-loan equities was inactive. Supplies of available cotton were moderate. Demand was very light. Average local spot prices were lower. Business slowly began to increase. Producers hoped for an increase in demand.

Daytime high temperatures were in the 50s to 70s. Overnight low temperatures were in the 30s to 60s. Mostly cloudy conditions with sunshine intervals characterized the weather pattern for the reporting period. Precipitation totals for the week measured up to three and three-quarter inches of rainfall. Scattered thunderstorms replenish much needed moisture to topsoil. According to the U.S. Drought Monitor, the soil conditions were mostly normal to abnormally dry in Mississippi and Louisiana. Fieldwork was hampered due to dry topsoil. More rain is needed to revive the groundwater supplies. Some producers continued to prep fields for spring. The Rayville Classing Office continued operations. Ginning operations progressed as a few gins continued pressing.

- A light volume of color 41 and better, leaf 3 and better, staple 36 and longer, mike 37-49, strength 27-33, and uniformity 80-82 traded for around 70.50 cents per pound, FOB car/truck (Rule 5, compression charges paid).
- A light volume of color 31-51, leaf 3 and better, staple 35-37, mike 37-49, strength 26-29, and uniformity averaging 80.5 traded for around 67.25, cents same terms as above.
- A moderate volume of color mostly 41 and better, leaf 4 and better, staple 36 and longer, mike 37-49, strength 25-33, and uniformity 79-83 traded for around 63.45, cents same terms as above.
- A moderate volume of CCC-loan equity cotton traded for around 10.00 cents to 12.50 cents per pound.

East Texas-South Texas

Spot cotton trading was slow. Supplies and producer offerings were light. Demand was moderate. Average local spot prices were lower. Producer interest in forward contracting was light. Trading of CCC-loan equities was inactive. Foreign inquiries were moderate. Interest was best from Pakistan, Taiwan, Turkey, and Vietnam.

In East Texas, mostly mild weather conditions with some scattered showers at the beginning of the week. Daytime high temperatures ranged from the 60s to the upper 70s. Nighttime low temperatures were in the mid-30s to the upper 60s. Accumulated precipitation totals ranged from trace amounts up to over one-quarter of an inch of moisture in some parts of the region. Pressing services continued at the gins. In South Texas, mostly sunny weather conditions were observed with some pockets of light rainfall. Daytime high temperatures ranged from the low 70s to the mid-80s throughout the week, with nighttime low temperatures varying from the 40s to the low 60s. Accumulated rainfall totals ranged from trace amounts in the Upper Coast up to over one-quarter of an inch in some areas of the lower Rio Grande Valley. Any future precipitation received will be beneficial for building soil moisture ahead of spring planting. A few gins continued pressing services in the Upper Coast, but most have completed their season.

West Texas-Kansas-Oklahoma

Spot cotton trading was active. Supplies and producer offerings were heavy. Demand was good. Average local spot prices were lower. Producer interest in

forward contracting was light. Trading of CCC-loan equities was inactive. Foreign inquiries were moderate. Interest was best from Pakistan, Taiwan, Turkey, and Vietnam.

In Texas, daytime high temperatures were in the low 50s to low 70s and overnight temperatures were in the 30s to 50s. Sunny, breezy conditions ruled. Harvesting progressed on the High Plains and was expected to be completed for most locations within the next three weeks, if the weather cooperates. Overall, harvesting was estimated around 95 percent completed on the High Plains, and ahead of expectations in the Rolling Plains. A significant number of acres remains to be harvested in the Rolling Plains. Modules were transported to the gin yards. Ginning continued and some plants neared the end of the season. Other plants expect to continue pressing operations into January. End-of-year meetings were held.

In Kansas, daytime temperatures were in the upper mid-40s to mid-60s, and overnight lows were in the 20s to 30s. Fieldwork advanced under partly cloudy and occasionally windy conditions. Harvesting was more than 95 percent completed. Ginning continued uninterrupted and was forecasted to be done in January. In Oklahoma, daytime high temperatures were in the 50s to 70s. Overnight temperatures were in the 30s to 40s. Harvesting neared completion under sunny, breezy conditions. Ginning plants continued processing seed cotton, and some had finished for the season.

• In Texas, a lot containing a heavy volume of color 31 and better, leaf 2 and 3, staple 37-39, mike averaging 44.6, strength averaging 31.7, and uniformity averaging 81.9 sold for 68.25 cents per pound, FOB warehouse, (compression charges not paid).

West Texas, Kansas & Oklahoma

- In Texas, lots containing a heavy volume of color 11 and 21, leaf 1 and 2, staple 36 and 37, mike 35-49, strength 27-32, and uniformity 77-82 sold for 69.25 to 70.25 cents per pound, FOB car/truck (compression charges not paid).
- A heavy volume of lots containing mostly color 31 and better, leaf 4 and better, staple 35-37, mike 35-44, strength 28-33, and uniformity 79-81 sold for 66.50 to 67.75 cents, same terms as above.
- Mixed lots containing a heavy volume of color 33 and better, leaf 2-7, staple 33-36, mike 31-52, strength 27-33, uniformity 77-82, and 25 percent extraneous matter sold for 59.50 to 62.25 cents, same terms as above.
- In Kansas, a heavy volume of color 41 and better, leaf 4 and better, staple 36 and 37, mike 36-48, strength 27-35, and uniformity 78-82 sold for 68.25 to 68.50 cents, same terms as above.

- In Oklahoma, a moderate volume of color 11 and 21, leaf 3 and better, staple 36 and 37, mike 41-47, strength 28-31, and uniformity 79-82 sold for around 69.00 to 69.50 cents, same terms as above
- Mixed lots containing a moderate volume of color 33 and better, leaf 4 and better, staple 35-37, mike 43-49, strength 31-34, and uniformity 78-82 traded for 62.00 to 64.00 cents, same terms as above.

Desert Southwest (DSW)

Spot cotton trading was inactive. Supplies and producer offerings were light. Demand was light. Producer interest in forward contracting was light. Average local spot prices were lower. Foreign mill inquiries were moderate.

Clear skies were the norm throughout the Desert Southwest (DSW) during the period. temperatures were pleasant with highs in the mid-60s to low 80s. Nighttime lows were mostly in the 40s, but some locales saw temperatures close to freezing. No rain was recorded. Harvest is nearing completion for the season. Yields in the DSW have been averaging between 2.5 to 3.5 bales per acre, with higher yields of around 4.5 bales per acre being reported in some locales. Throughout the territory, modules lined fields and were trucked to gins yards. A couple of gins experienced mechanical issues, which slowed operations. Pressing operations are expected to continue until mid-February, but some gins will wrap up before New Year's Day. San Joaquin Valley (SJV)

Spot cotton trading was inactive. Supplies and demand were light. No forward contracting or domestic mill activity was reported. Average local spot prices were lower. Foreign mill inquiries were light.

Weather conditions in the San Joaquin Valley, were partly cloudy with foggy skies. Daily temperatures were in the 50s and 60, with nightly lows in the 30s and 40s. Early in the week, a storm system brought welcomed rain showers with total accumulations of around one-quarter of an inch. This will help improve soil moisture levels. Gins continued processing modules off the gin yards.

Ginning is expected to continue until February 2025 for some gins, while others have already finished for the season. The Department of Water Resources reported on December 18 that the statewide snowpack levels were at 31 percent of the April 1 average. <u> American Pima (AP)</u>

Spot cotton trading was inactive. Supplies were moderate. Demand was light. No forward contracting or domestic mill activity was reported. Average local spot prices were steady. Foreign mill inquiries were light.

In the San Joaquin Valley, weather conditions were partly cloudy with foggy skies. Daily temperatures were in the 50s and 60 with nightly lows in the 30s and 40s. A storm system early week brought rain showers that totaled around one-quarter of an inch, this will be beneficial to soil moisture levels. The Department of Water Resources reported on December 18 that the statewide snowpack levels were at 31 percent of the April 1 average. This year's harvest is completed. Ginning is expected to continue until February 2025 for some gins, while others have already finished for the season. In the Desert Southwest, daily temperatures ranged from the 60s to the 80s, with nightly lows close to freezing. No rain was recorded during the period. Harvesting activities were finished in most areas and ginning operations continued. Ginning could run well into March 2025 for some gins. Producers continue to be disappointed in yields with a range of 1.75 to 3 bales per acre reported. 

Net sales of Upland totaling 194,900 RB for 2024/2025 were up 27 percent from the previous week, but down 19 percent from the prior 4-week average. Increases primarily for Vietnam (42,400 RB, including 400 RB switched from Hong Kong), Pakistan (37,000 RB, including decreases of 2,200 RB), Turkey (32,100 RB), Indonesia (16,000 RB, including 200 RB switched from Japan), and Mexico (11,100 RB), were offset by reductions for Hong Kong (400 RB). Total net sales of 6,900 RB for 2025/2026 were for Mexico. Exports of 128,600 RB were down 6 percent from the previous week and 10 percent from the prior 4-week average. The destinations were primarily to Pakistan (25,500 RB), Vietnam (23,800 RB), China (22,700 RB), Bangladesh (11,700 RB), and Mexico (10,200 RB). Net sales of Pima totaling 500 RB for 2024/2025--a marketing-year low--were down 93 percent from the previous week and 94 percent from the prior 4-week average. Increases were reported for India (200 RB, including decreases of 400 RB), Mexico (200 RB), and Japan (100 RB). Exports of 12,000 RB were up 84 percent from the previous week and up noticeably from the prior 4-week average. The destinations were primarily to India (6,600 RB), Peru (1,700 RB), Egypt (1,100 RB), Pakistan (900 RB), and China (900 RB).

Exports for Own Account: For 2024/2025, the current exports for own account outstanding balance of 8,400 RB, all China.

USDA ANNOUNCES SPECIAL IMPORT QUOTA #10 FOR UPLAND COTTON December 19, 2024

The Department of Agriculture's Commodity Credit Corporation announced a special import quota for upland cotton that permits importation of a quantity of upland cotton equal to one week's domestic mill use. The quota will be established on December 26, 2024, allowing importation of 6,905,322 kilograms (31,716 bales of 480-lbs) of upland cotton.

Quota number 10 will be established as of December 26, 2024, and will apply to upland cotton purchased not later than March 25, 2025, and entered into the U.S. not later than June 23, 2025. The quota is equivalent to one week's consumption of cotton by domestic mills at the seasonally-adjusted average rate for the period July 2024 through September 2024, the most recent three months for which data are available.

Future quotas, in addition to the quantity announced today, will be established if price conditions warrant.
