Subscribe to all Cotton Market reports Spot quotations averaged 259 points lower than the previous week, according to the USDA, Agricultural Marketing Service's Cotton and Tobacco Program. Quotations for the base quality of cotton (color 41, leaf 4, staple 34, mike 35-36 and 43-49, strength 27.0 - 28.9, and uniformity 81.0 - 81.9) in the seven designated markets averaged 61.05 cents per pound for the week ending Thursday, March 6, 2025. This is the lowest weekly average since August 15, 2024 when the average was 60.46. The weekly average was down from 63.64 cents last week and from 90.42 cents reported the corresponding period a year ago. Daily average quotations ranged from a high of 61.97 cents on Monday, March 3 to a low of 59.74 cents on Tuesday, March 4. Spot transactions reported in the Daily Spot Cotton Quotations for the week ended March 6 totaled 12,601 bales. This compares to 22,126 reported last week and 6,310 bales reported the corresponding week a year ago. Total spot transactions for the season were 768,348 bales compared to 781,158 bales the corresponding week a year ago. The ICE May settlement price ended the week at 65.21 cents, compared to 66.60 cents last week.

Southeastern Markets Regional Summary

Spot cotton trading was inactive. Supplies and offerings were moderate. Demand was moderate. Average local spot prices were lower. Trading of CCC-loan equities was inactive.

Mostly sunny conditions prevailed across the lower Southeast early in the period, preceding a line of severe storms that moved across the region later in the week. Daytime temperatures were in the 60s and 70s. Nighttime lows were mostly in the 40s and 50s. The fast moving thunderstorms brought moderate precipitation and heavy winds to areas across Alabama, the Florida Panhandle, and Georgia. Rainfall totals measured around one to two inches where the heaviest downpours were recorded. The moisture improved from abnormally dry to moderate drought conditions across the region. Ginning was essentially completed for the season, but a few gins remained on gin days as they processed the last remaining modules and round bales.

Mostly sunny to partly cloudy skies dominated the weather pattern across the upper Southeast during much of the period. Daytime high temperatures were in the 60s and 70s. Nighttime lows were mostly in the 30s and 40s. A strong weather system moved across the Carolinas and Virginia early in the week, bringing gusty winds, moderate rainfall, and thunderstorms to the region. Producers welcomed the moisture, which helped ease abnormally dry to moderate drought conditions. Gins completed pressing operations for the season.

Textile Mill

Domestic mill buyers inquired for a volume of color 41, leaf 4, and staple 34 and longer for second through fourth quarter 2025 delivery. No sales were reported. The undertone from mill buyers remained cautious as they balanced yarn production schedules with finished product orders.

Demand through export channels was moderate. Agents for mills in Taiwan inquired for a moderate volume of color 42 and 52, leaf 4 and better, and staple 32 and longer for prompt shipment. No sales were reported.

North Delta

Trading of spot cotton and CCC-loan equities was inactive. Supplies of available cotton were light. Demand was very light. Average local spot prices were lower. The continuous decline in market prices have deterred forward contracting decisions and the flow of business. Some growers were trying to secure financing, and they continue to monitor the market.

Mostly cloudy skies characterized the weather pattern for the reporting period. The National Weather Service issued wind advisories. Cool air moved through the region, dropping seasonably high daytime temperatures in the low 70s into the mid-40s. Wind speeds ranging from 25 to 35 miles per hour with gusts up to 45 miles per hour were reported. Nighttime temperatures were in the 20s to the 50s. Precipitation totals measured from trace amounts to around three-quarters of an inch of rain. Local sources reported standing water in fields, and as a result, fieldwork was inactive. Gusty winds helped the fields dry quicker, and growers hoped for sunny weather conditions going forward. According to the U.S. Drought Monitor released on March 6, in Arkansas, there was no drought to report in cotton-growing areas. In Tennessee, soil conditions varied from abnormally dry to severe drought in some locales.

South Delta

Trading of spot cotton and CCC-loan equities was inactive. Supplies of available cotton was light. Demand was very light. Average local spot prices were lower. No forward contracting was reported. Business was very slow. Many producers are still weighing their options financially and working to secure financing for the crop.

Partly cloudy skies prevailed throughout the reporting period. Cool winds dropped daytime high temperatures in the 70s into the 50s. Nighttime low temperatures were in the 30s to the 50s. The National Weather Service issued flood and wind advisories. Excessive rainfall in some areas within Mississippi resulted in increasingly high-level flood warnings. On Wednesday March 5, the water level in the Mississippi River was at 43.60 feet, and as of March 6, the water level has increased by 4.40 feet to 48.00 feet. High wind speeds ranging from 20 to 30 miles per hour with gusts up to 45 miles per hour were reported. Afternoon thunderstorms dominated the territory, accumulating three-quarters of an inch of precipitation. According to the U.S. Drought Monitor report released on March 6, in Mississippi, the majority of the region's soil condition was abnormally dry. In Louisiana, soil conditions showed substantial moisture. Field activity was inactive.

East Texas-South Texas

Spot cotton trading was slow. Supplies and producer offerings were light. Demand was light. Average local spot prices were lower. Producer interest in forward contracting was light. Trading of CCC-loan equities was inactive. Foreign mill inquiries were light. Interest was best from Bangladesh, Pakistan, and Vietnam.

Warm, spring-like weather persisted, but some areas of East Texas received severe weather that included tornado watches and heavy rainfall. Daytime high temperatures were in the 70s and 80s. Nighttime temperatures were in the upper 30s to the upper 60s. Accumulated rainfall totals ranged from trace amounts to one-half of an inch of precipitation in some areas. Fieldwork and preparations for other row crops were underway. Planting is expected to begin in late March to early April in the Blackland Prairies. The insurance price discovery period for East Texas closed on February 28 at 69.00 cents per pound. In South Texas, mostly dry and windy conditions were observed during the week. Daytime high temperatures ranged from the upper 70s to the 90s, and nighttime low temperatures were in the low 50s to the 70s. Stray showers brought trace amounts of moisture to some locales of South Texas. Soil moisture and weather conditions in areas from the Coastal Bend south continue to be dry, and rainfall would be beneficial. In the lower Rio Grande Valley, planting activities commenced. In the Upper Coast, fieldwork and planting for other commodities expanded as windy weather conditions permitted.

West Texas-Kansas-Oklahoma

Spot cotton trading was active. Supplies and demand were moderate. Producer offerings were light. Average local spot prices were lower. Producer interest in forward contracting was light. Trading of CCC-loan equities was slow. Foreign mill inquiries were moderate. Interest was best from Bangladesh, Pakistan, and Vietnam.

In Texas, unseasonably warm temperatures prevailed with daytime high temperatures in the low 50s to low 80s. Overnight low temperatures were in the 20s to the 50s. Strong winds containing over 70 miles per hour gusts coupled with low humidity, and warm temperatures spurred Red Flag Alerts, and Fire Weather Watches issued by the National Weather Service (NWS). Scattered showers early in the period brought a light amount of rain, hail, and gusting winds. The storm brought around one-half of an inch of moisture and was not widespread. More precipitation will be needed ahead of planting. Row crop preparation and pre-plant irrigation were underway after the winds calmed.

In Kansas, mainly sunny and windy conditions ruled with daytime temperatures in the low 50s to mid-70s, and overnight lows in the 20s to 40s. The NWS issued a mid-period High Wind Warning as a cold front moved across the state. Trace amounts of precipitation was received at some locations. Generally, producers were discouraged by commodity market prices and were unsure of which crop to plant. In Oklahoma, daytime high temperatures were in the upper 50s to low 80s. Overnight temperatures were in the 30s to 40s. Some locations received up to three-quarters of an inch of rainfall as a quick cold front pushed through the region. Cotton growing-areas need more rainfall ahead of Spring planting.

East Texas-South Texas

• A light volume of color 31 and 41, leaf 2 and 3, staple 35 and 36, mike averaging 46.1, strength averaging 29.1, and uniformity averaging 81.6 sold for around 62.00 cents per pound, FOB warehouse (compression charges not paid).

West Texas, Kansas & Oklahoma

- In Texas, a light volume of color 31 and better, leaf 3 and better, staple 37, mike 35-44, strength 28-32, and uniformity 78-82 sold for around 66.75 cents per pound, FOB car/truck (compression charges not paid).
- Mixed lots containing a heavy volume of color 32 and better, leaf 4 and better, staple 33 and 34, mike 33-53, strength 25-32, and uniformity 76-82 sold for 58.00 to 60.00 cents, same terms as above.
- In Kansas, mixed lots containing a light volume of color 52, 43, and 53, leaf 4-7, staple 34-37, mike 41-45, strength 29-32, and uniformity 79-82 sold for 52.75 to 53.00 cents, same terms as above.
- In Oklahoma, a lot containing a light volume of color 11 and 21, leaf 3 and better, staple 36, mike 36-40, strength averaging 30.00, and uniformity averaging 81.3 traded for around 60.50, same terms as above.
- A heavy volume of CCC-loan equities traded for 4.25 to 5.00 cents.

Desert Southwest (DSW)

Spot cotton trading was active. Supplies and producer offerings were light. Demand was light. Producer interest in forward contracting was light. Average local prices were lower. No forward contracting or domestic mill activity was reported. Foreign mill inquiries were light.

Temperatures in Arizona throughout the period were variable. Daily highs at the beginning of the week ranged from the upper 70s to mid-80s. Toward the end of the week, thunderstorms and windy conditions blew in cooler daytime temperatures in the mid-to-upper 50s. Nightly lows were in the 40s and 50s. Rain totals of less than one-tenth of an inch were recorded in some locales.

In Yuma, AZ, initial planting continued. In Safford, fieldwork was underway as rows were made and fields were pre-plant irrigated. Weather conditions in El Paso, TX and New Mexico were sunny to partly cloudy with occasional gusty winds. Daily temperatures were in the 60s and 70s with nightly lows in the 30s and 40s. Wind and dust advisories were issued. No rain was recorded during the period. Growers pre-plant irrigated fields and prepared rows for planting.

San Joaquin Valley (SJV)

Spot cotton trading was inactive. Supplies and demand were light. No forward contracting or domestic mill activity was reported. Average local prices were lower. Foreign mill inquiries were light.

Partly cloudy skies dominated the weather pattern during the period. Daily temperatures were in the upper 70s at the beginning of the period, but cooled into the 50s by week's end. The cold front brought some welcome rain to the territory, with some locales recording close to one and one-half inches of

precipitation. Nighttime lows were in the 40s. Growers were making plans as the planting season approaches, which could commence in the next two to three weeks. Due to cotton prices and other factors, some growers may shift to other commodities such as corn, but that remains to be seen.

American Pima (AP)

Spot cotton trading was active. Supplies were moderate. Demand was light. No forward contracting or domestic mill activity was reported. Average local spot prices were lower. Foreign mill inquiries were light.

In the San Joaquin Valley, temperatures were in the upper 70s at the beginning of the period but cooled into the 50s by week's end. The cold front brought some welcome rain to the territory, with some locales recording close to one and one-half inches of precipitation. Growers were making plans as the planting season approaches, which could commence in the next two to three weeks. Due to cotton prices and other factors, some growers may shift to other commodities such as corn, but that remains to be seen. In the Desert Southwest, temperatures ranged from the 60s to the 80s with nightly lows in the 40s and 50s. No rain was recorded during the period. In Yuma, AZ, initial planting began in some fields. The Visalia Classing Office continues to class samples received from gins in Arizona.

Net sales of Upland totaling 241,500 RB for 2024/2025 were up 45 percent from the previous week and 6 percent from the prior 4-week average. Increases were primarily for Vietnam (73,100 RB, including 6,500 RB switched from China and 200 RB switched from South Korea), China (46,800 RB), Pakistan (32,600 RB, including decreases of 1,200 RB), Turkey (32,000 RB), and Thailand (18,900 RB, including decreases of 200 RB). Net sales of 105,600 RB for 2025/2026 were primarily for Pakistan (75,500 RB), Nicaragua (15,900 RB), Turkey (11,100 RB), and Vietnam (2,200 RB). Exports of 334,000 RB--a marketing-year high--were up 25 percent from the previous week and 28 percent from the prior 4-week average. The destinations were primarily to Vietnam (100,100 RB), Pakistan (65,400 RB), Turkey (46,000 RB), China (23,100 RB), and Bangladesh (17,700 RB). Net sales of Pima totaling 10,900 RB for 2024/2025 were down 51 percent from the previous week and 12 percent from the prior 4-week average. Increases were primarily for India (4,000 RB, including decreases of 400 RB), China (3,900 RB), Pakistan (1,100 RB), Hong Kong (700 RB), and Colombia (300 RB). Exports of 4,000 RB were down 60 percent from the previous week and 52 percent from the prior 4-week average. The destinations were primarily to India (2,100 RB), Thailand (600 RB), Turkey (400 RB), Vietnam (400 RB), and Guatemala (300 RB).

Optional Origin Sales: For 2024/2025, the current outstanding balance of 8,800 RB, all Pakistan.

Exports for Own Account: For 2024/2025, the current exports for own account outstanding balance of 5,300 RB, all China.
