National FOB shell egg weighted average prices are mostly steady to lower, although lightly tested. The undertone is generally steady. Demand into retail channels ranges light to at times fairly good. Food service demand is light to moderate. Offerings are light to moderate. Supplies are moderate. Market activity is moderate. California weighted average delivered prices are not well tested. The undertone is weak. Retail and food service demand is in a full range of light to occasionally fairly good. Offerings are light to moderate. Supplies are moderate. Market activity is slow to moderate. The 6-Area Total shell egg inventory declined 5.7% when compared to a week ago.
