Grain Report for 8/11/2023 - Final

Compared to the last report: Premiums and demand were moderate. According to the U.S. Drought Monitor, A strong area of mid-level high pressure, anchored over the southern tier of the country, continued to promote above-normal temperatures and mostly dry weather across the Rio Grande Valley, Texas, and the lower Mississippi Valley. Weekly temperatures (August 2 to 8) averaged more than 6 degrees F above normal across portions of Louisiana, Texas, and southern New Mexico. The persistence of this pattern led to rapidly developing and intensifying drought across Texas and the lower Mississippi Valley. The Monsoon remains suppressed with increasing short-term drought across Arizona, New Mexico and southwest Colorado. Frequent rounds of heavy rainfall occurred from the central Great Plains southeastward to the middle Mississippi Valley. During the first week of August, parts of Missouri received 5 to 10 inches (locally more) of rainfall. The wet start to August resulted in improving drought across parts of the Corn Belt. Farther to the north, drought continues to intensify across Wisconsin. On August 7, a severe weather outbreak with heavy rainfall affected the East. Short-term drought expanded this past week across parts of the Hawaiian Islands. The next available Non GMO/GE report will be August 18, 2023.
